Advocating Congregation or Advocating Faith Organization*

by completing at least six of the activities below

▪ **Education:**

- Invite a speaker from Lutheran Advocacy Ministry-NM to teach or preach in your congregation
- Organize a group or forum to learn about issues on the LAM-NM Advocacy Agenda
- Study the ELCA Social Statements or similar documents from your denomination or faith tradition
- Keep advocacy visible within your congregation through communications and/or displays

▪ **Action:**

- Send people to the annual LAM-NM Fall Conference
- Form an advocacy team in your congregation to help mobilize responses to LAM-NM Action Alerts
- Encourage people to join the LAM-NM Advocacy Network
- Do an offering of letters to state public officials regarding a current LAM-NM issue
- Promote voter registration in your community
- Send people to the LAM-NM Bishop's Luncheon & Issues Briefing during legislative sessions
- Include the ministry of advocacy in your corporate prayers
- Host a non-partisan meeting or forum (relating to LAM-NM issues) with the state legislators who represent the area that includes your church's location
